SAFETY INSTRUCTIONS

READ AND SAVE THESE INSTRUCTIONS

WARNING: RISK OF ELECTRICAL SHOCK

Safety precautions should always be used when operating this or any electrical appliance. Decrease the risk of electrocution, electric shock, injury or fire by reading and following all the warnings below.

Use only as described in this Envion EA150 air purifier manual. To reduce the risk of electric shock, do not attempt to service the product in any way other than in the manner described in the **"Cleaning & Maintenance"** section of this manual.

READ ALL INSTRUCTIONS BEFORE OPERATING THE AIR PURIFIER.

- » This product operates at 120V AC, 60Hz only.
- » Do not run cord under carpeting. Do not cover cord with throw rugs, runners, or similar coverings. Arrange cord away from traffic area and where it will not be tripped over.
- » Do not operate the product in any greasy environment, such as in the kitchen. This product is not intended to filter oil or grease from the air.
- » Do not use the Envion EA150 air purifier in bathrooms or other humid environments. Do not use near fireplaces or in areas where flammable or combustible vapors or products may exist. Do not use near sinks, bath, countertops or other appliances that can leak or splash water on the air purifier.
- » Always unplug the power cord from the electrical outlet when the purifier is not in use, before cleaning, inserting or removing parts or before moving to another location.
- » Never run the air purifier unless it is fully assembled.
- This appliance has a polarized plug (one blade is wider than the other). To reduce the risk of electric shock, this plug is intended to fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Do not attempt to defeat this safety feature.
- » Always turn off all controls before unplugging the Envion air purifier from the outlet.
- » Attempting to service the Envion EA150 air purifier in any way that is not described in this owner's manual will cause the warranty to be voided and could cause serious personal injury to the user and/or result in considerable damage to the unit.
- » Do not place the cord near a heated surface.
- » Do not operate this product with a damaged cord or plug. Discard the product or return to an authorized service facility for examination and/or repair.

- » Never use the power cord to pick up, carry, drag, pull, or lift the Envion EA150 air purifier. Do not pull the cord against or around sharp corners and edges. This could result in injury to the user or damage to the cord.
- » Always remove the plug from its power outlet by holding onto the plug itself and pulling gently.
- » Never pull on the cord itself to unplug it from its power outlet.
- » Use care when operating the Envion EA150 air purifier by keeping all foreign objects, fingers, body parts, hair, loose clothing and jewelry away from openings.
- » Never touch the Envion EA150 air purifier or its plug when your hands are wet.
- » The Envion EA150 air purifier is an electrical appliance. Adult supervision is required when operating the Envion in the presence of children.
- » To reduce the risk of fire or electric shock, do not use this air purifier with any solid-state speed control devices.



OPERATING THE ENVION AIR PURIFIER

Before using the Envion EA150 air purifier, please read the following important information. **Specifications:**

Locate a level surface on which to place the Envion air purifier near a 120V outlet (follow warnings in the **"SAFETY INSTRUCTIONS"** and **"IMPORTANT WARNINGS"** sections of this manual). Position your Envion air purifier at least one foot (12 inches) from the wall. Plug in the unit.



- 1. Do not place near fans.
- 2. Keep both sides of the unit at least 1 foot away from a wall.
- 3 Do not place the unit near curtains.
- 4. Placing the unit close to the source of air pollution is an effective way to improve indoor air quality.



Note:

DO NOT run the Envion EA150 air purifier with a broken filter. Replace the filter if the filter has a tear or a hole in it.



OPERATING THE ENVION AIR PURIFIER

CONTROLS/SETTINGS:

Power Control – To operate the Envion air purifier, press ON/OFF button to turn on the air purifier. Press SPEED button to cycle through the fan speeds.

Fan Speed Control – The Envion air purifier, has three different speeds of cleaning, **HI**, **MED** and **LOW**. Press the SPEED button until your desired speed.

MAINTENANCE

The Envion EA150 professional air purifier is almost maintenance free! Our 3-in-1 True HEPA filter lasts 6 to 9 months, depending on use and environment conditions. The **"Change Filter"** light will turn on when it's time to change the filter.

Before replacing the True HEPA filter of your Envion EA150 professional air purifier, turn off and unplug the unit from the electrical outlet and read all safety instructions and important warnings in this owner's manual.


Replacing the 3-in-1 True HEPA Filter

- 1. Make sure unit is turned off and unplugged. Release the inlet grill by rotating is counterclockwise and then lift off. (see diagram of Main Parts).
- 2. Remove the inlet grill from the unit as shown below.
- 3. Grasp the left and right frames of the True HEPA filter through the indentations on the sides of the filter enclosure and remove the filter.
- 4. Insert a new True HEPA filter, then snap the inlet grill back into position and rotate clockwise until it locks into place. Line up the ♥ on the grill with the on the air purifier. These are on the right side of the unit when facing the front grill.
- 5 . Plug in the unit and then turn it on. Press the Speed & Power buttons together for **3 seconds** to reset the "Change Filter" light.

To Order A Replacement 3-in-1 True HEPA Filter

The True HEPA filter should be changed every 6 to 9 months. Simply contact our customer service department at **1.800.875.8577** or go online at **envionproducts.com.**


Cleaning the Pre-filter

To keep the unit operating at its maximum performance, it is recommended to vacuum the Pre-filter every 3 months.

- 1. Remove the front grill by turning it counter-clockwise.
- 2. Remove the filter by pulling on the white tab on front of filter.
- 3. To clean the filter, use the brush or crevice attachment with a vacuum cleaner. Run the attachment along the surface of the front of the filter, the side with the white tab.
- 4. Once the filter has been cleaned, replace the filter back into the unit in the reverse order.


Cleaning External Surfaces

- 1. Turn off and unplug unit.
- 2. Use a washcloth slightly dampened with a little water and dishwashing soap to wipe the outer case surfaces.
- 3. Do not allow water to slip into the internal parts as this could damage your unit and result in electrical shock and injury to you.
- 4. Allow the unit to thoroughly dry before use.



TROUBLESHOOTING

PROBLEM	REASON	SOLUTION
Unit will not operate	ON/OFF button not turned to ON position.	Press the ON/OFF button.
	Unit is unplugged.	Check to ensure unit is plugged in.
	The inlet grill has not been installed and locked into place.	Check to make sure filter is properly installed and locked into place.
Reduced airflow or poor filtering	The inlet or outlet grill may be blocked.	Check to ensure nothing is blocking the air inlet and air outlet.
	3-in-1 True HEPA filter maybe clogged.	Replace with a new 3-in-1 True HEPA filter, if necessary.

This warranty does not cover damage caused by accident, misuse or any use other than as intended and described in this product manual, or damage resulting from failure to maintain and clean this product as specified in this product manual. This warranty applies only to the original purchaser of the Envion EA150 air purifier.

ARBITRATION AGREEMENT

PLEASE READ THIS AGREEMENT CAREFULLY. YOU ACCEPT THE TERMS OF THIS AGREEMENT BY RETAINING THE PRODUCT(S) SHIPPED IN CONNECTION WITH THIS AGREEMENT (THE "PRODUCTS") FOR MORE THAN THIRTY (30) DAYS AFTER RECEIPT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU MAY RETURN THE PRODUCT TO COMPANY WITHIN THIRTY (30) DAYS OF RECEIPT FOR A FULL REFUND.

THIS ARBITRATION AGREEMENT ("AGREEMENT") AFFECTS YOUR LEGAL RIGHTS AND REMEDIES BY PROVIDING THAT DISPUTES BETWEEN YOU AND THE MANUFACTURER, DISTRIBUTOR AND/OR SELLER OF THIS PRODUCT (COLLECTIVELY, "COMPANY"), MUST BE RESOLVED THROUGH BINDING ARBITRATION AND NOT IN COURT. IT ALSO PROVIDES THAT ANY DISPUTE CANNOT BE RESOLVED IN A CLASS ACTION OR OTHER PROCEEDING WHERE YOU REPRESENT OTHER PERSONS OR OTHER PERSONS REPRESENT YOU, AND THAT NO CLASS OR REPRESENTATIVE ARBITRATIONS ARE PERMITTED. PLEASE CAREFULLY READ ALL TERMS IN THIS AGREEMENT.

1. RESOLUTION OF CLAIMS OR DISPUTES.

Any claim or dispute between you and Company (or any of Company's subsidiaries or affiliates) arising out of or relating in any way to the Product or this Agreement shall be resolved through final, binding arbitration. This arbitration obligation is reciprocally binding on both you and the Company and applies regardless of whether the claim or dispute involves a tort, fraud, misrepresentation, product liability, negligence, violation of a statute, or any other legal theory. Both you and Company specifically acknowledge and agree that you waive your right to bring a lawsuit based on such claims or disputes and to have such lawsuit resolved by a judge or jury.

2.LIMITATION OF LEGAL REMEDIES.

All arbitrations under this Agreement shall be conducted on an individual (and not a class-wide) basis, and an arbitrator shall have no authority to award class-wide relief. You acknowledge and agree that this Agreement specifically prohibits you and the Company from commencing arbitration proceedings as a representative of others or joining in any arbitration proceedings brought by any other person. The parties agree that no class or representative actions of any type are permitted.

3.ARBITRATION PROCEDURES.

a. Before instituting an arbitration, if you have any dispute, we strongly encourage you to contact the Company to try to resolve the matter by calling 800.218.3560, although you are not required to do so.

b. The arbitration of any claim or dispute under this Agreement shall be conducted in accordance with the expedited procedures set forth in the JAMS Comprehensive Arbitration Rules and Procedures as those Rules exist on the date you receive the Product, including Rules 16.1 and 16.2 of those Rules. These rules and procedures are available by calling JAMS or by visiting its web site at www.jamsadr.com. The arbitration of any claim or dispute under this Agreement shall be conducted by an arbitrator who has at least five years of experience conducting arbitrations.

c. The arbitration of any claim or dispute under this Agreement shall be conducted in the State of California or the location in which you received this Agreement. For claims of \$10,000 or less, you may choose whether the arbitration proceeds in person, by telephone, or based only on submissions.

d. The Company shall pay costs for the arbitration of claims, including any JAMS Case Management Fee and all professional fees for the arbitrator's services. The Company shall pay the fees and costs of its own counsel, experts and witnesses and shall not be able to recoup them from you even if you do not prevail in the arbitration. Unless otherwise provided by law, you acknowledge and agree that you shall pay the fees and costs of your own counsel, experts and witnesses.

4. CHOICE OF LAW.

The arbitration provisions of this Agreement and any arbitration conducted pursuant to the terms of this Agreement shall be governed by the Federal Arbitration Act (9 U.S.C. Secs. 1-16). In this respect, the parties acknowledge that this Agreement involves a transaction conducted in interstate commerce. Otherwise, this Agreement and the rights of the parties hereunder shall be governed by and construed in accordance with the laws of the State of California, exclusive of conflict or choice of law rules.

5. SEVERABILITY.

If any provision of this Agreement is declared or found to be unlawful, unenforceable or void, such provision will be ineffective only to the extent that it is found unlawful, unenforceable or void, and the remainder of the provision and all other provisions shall remain fully enforceable.
